**1.** THE NEW AFRICAN WAY On June 22, IDRC's Dr Connie Freeman will be in Vancouver to speak at a public event about the major changes happening in Africa. Dr Freeman is the Regional Director of the East and Southern Africa office of Canada's International Development Research Centre (IDRC), which is supporting research in 22 African-countries.

The public presentation - The New African Way -- begins at 7 p.m. in the Alice MacKay Room, Vancouver Public Library, and 350 West Georgia Street. Parking is available and the nearest Skytrain stops are Stadium and Granville stations.

Based in Nairobi, Kenya and with over 30 years working on Africa issues, Dr Freeman brings her first hand insights into major shifts in thinking which are occurring on the continent. Historically, Dr Freeman feels that a major barrier to development in Africa has been the two-sided psychological state of "dependency" between African and Western countries. In recent years, she has seen this dependency begin to erode. If this trend continues, Dr Freeman feels new attitudes will need to occur with both Africans and Western/Northern partners. Dr Freeman's presentations are on the eve of the G-8 Summit which Tony Blair is hosting July 6-8 in Scotland. Africa and climate change are priorities for the discussions amongst the industrial leaders.

Canada's International Development Research Centre is one of the world's leading institutions in the generation and application of new knowledge to meet the challenges of international development. For more than 30 years, IDRC has worked in close collaboration with researchers from the developing world in their search for the means to build healthier, more equitable, and more prosperous societies.

VANCOUVER, BC - On June 24th, *The Street Repertory Theatre Company* fires its opening salvo into the urban theatre scene with an exploration of competitive aggression through the eyes of two Canadian playwrights, Daniel MacIvor and Michel Garneau. The evening promises a double-barreled bill of provocative Canadian plays in this inaugural battle in *Street Rep's* 

war on urban indifference.

Directed by Amanda Lockitch, MacIvor's *Never Swim Alone* and Garneau's *Warriors* will be onstage at the Pacific Theatre from Friday, June 24th to Saturday, July 9th, 2005. That both plays are Canadian is also significant for Fisher: "Given our proximity both geographically and culturally to the U.S., the Canadian perspective is increasingly important. As well as providing a mirror with which Canadians can better understand themselves, it provides an important perspective for anyone concerned with global politics." Perspective is what this performance is all about, for in addition to the director's and actors' interpretations of the scripts, the audience will get to see the perspective of two local artists, as The Cold World graffiti crew and Jason Cusator are each producing an art series based on the plays.

In the past years, we have written hundreds of letters, collected thousands of signatures, and organized dozens of demonstrations. demands for regularization call for the recognition and affirmation of rights and status of people residing in Canada without permanent residency- non status peoples, refugees, and temporary workers.

Excerpt from a speech made by Lucy Parsons, black woman, activist, anarchist, and wife of the Haymarket martyr, Albert Parsons. Lucy attended and addressed the founding convention of the IWW on the afternoon of June 28, 1905. On the afternoon of June 29, in relation to women?s oppression she said, ?There was never a greater truth uttered. We are the slaves of the slaves. We are exploited more ruthlessly than men. Wherever wages are to be reduced the capitalist class use women to reduce them, and if there is anything that you men should do in the future it is to organize the women. And I say that if the women had inaugurated a boycott of the State Street stores since the Teamsters strike, the stores would have surrendered long ago. I do not stand before you to brag. I had no man connected with that strike to make it of interest to me to boycott the stores, but I have not bought one penny?s worth there since that strike was inaugurated. I intended to boycott all of them as one individual at least, so it is important to educate the women.

Now, I wish to show my sisters here that we fasten the chains of slavery upon our sisters, sometimes unwittingly, when we go down to the department store and look around so cheap. When we come to reflect it simply means the robbery of our sisters, for we know that the things cannot be made for such prices and give women who made them fair wages.?

Councillor Louie: The Walmart decision has been postponed for a week, clearly to allow time for you to return to council and vote in favour of it. If you do so you will be contributing to the ongoing march to the bottom that Walmart represents; ruining an already damaged neighbourhood; violating the hopes and dreams of the majority of Vancouverites; and caving in to the endless demands of a group of corporate vampires. I beg you to reconsider your vote, in the historical context of the quote above. The kind of oppression Lucy Parsons fought will always thrive as long as there are politicians willing to sacrifice the public good, whether here or in other countries.

I am writing to you today on a matter of extreme importance, not only for the Kwantlen University College Student Association (KSA, Local 26 of the Canadian Federation of Students), but also for the whole of the Canadian student movement.

A BC Supreme Court ruling was handed down on May 12, 2005 giving control of the KSA to a Kwantlen administration supported group of candidates in the KSA election. This case is a huge setback for students who believe that student organizations should operate free from interference from our institution's administrators. Here is the story:

On April 25, 2005 Kwantlen University College VP Derek Francis, met with the leader of a group of candidates, Aaron Takhar, who ran under the slate name Reduce All Fees Party (RAF) in the KSA election, to discuss how his slate was the proper KSA board of directors, that the current Board was preventing them from taking office because we were corrupt, and asked if the administration could help them out. Mr. Francis replied that if some proof could be provided of their victory that he would 'consider his options'. On April 27, the KSA Ombudsperson, acting completely outside his authority according to KSA Regulations and Bylaws, wrote a letter to Mr. Francis, that the new board of the KSA: RAF. Mr. Francis, at the request of Mr. Takhar promptly locked the current Board of the KSA out of their offices, posted security outside the doors and allowed RAF sole access. The current Board of the KSA sought a legal injunction against KUC for being locked out, for a declaration of who the winners of the KSA election were and costs from KUC for breaking our lease and costs associated with the lock-out.

Kwantlen University College should not have taken a side in the matter. If Mr. Takhar felt that there were problems with the KSA's election, and it was not perfect, RAF should have petitioned the court to review the election. Kwantlen University College should have pointed RAF in this direction instead of helping them perform a hostile take-over of the KSA offices. It is entirely possible that a court petition

would have had the very similar results.

The Court's decision gave control of the KSA offices to the administration-supported group of RAF candidates. There were a few problems with the judges decision, like failing to review what happened during the KSA election but using it as a basis for who should constitute the KSA's Board for the next year; and also failed to label Kwantlen University College's actions as appropriate or not. This is especially disturbing because the same day we were locked out of our offices, the KSA filed a \$500,000 lawsuit against Kwantlen University College for failing to collect and remit our fees properly. The judge was informed of this.

It is my fear that this decision can/will be used by administrations across the country to justify interfering and breaking contracts with, student organizations for their own ends. It is also my fear that this case will be used by right leaning governments as proof that students can't run their own organizations, and require administrators to watch over them and take control when 'necessary'. It is also my fear that labour unions will use it for the same reason. KSA staff abandoned the current Board and helped out RAF during the dispute at the direction of their union, CUPE 2396. The KSA Ombudsperson is in the union.

What happened to the KSA, happened because Kwantlen University College took a side in the KSA's election. Without their interference there would have been no injunctive hearing, and the election would have been properly reviewed to determine who the Board of Directors should be.

The decision was from Mr. Justice Maczko, in the case of Kwantlen Student Association v. Kwantlen University College and Mat Huff, Aaron Takhar, Javin Khatri, Joey Atwal and Mariana Nakhla.

I should also note that the Canadian Federation of Students sat on the sidelines and waited for the court to make its decision before openly supporting one side over the other. The CFS did not condemn the actions of

Kwantlen University College.

During this dispute there was a provincial election in full swing. The KSA had put together an extremely aggressive advertising campaign designed to make post-secondary education a key voting issue in the election. It called for a reduction in tuition, increase in funding and re-instituting a system of up-front non-repayable student grants (which were eliminated the year before). Our campaign efforts were derailed the second week of the election by this dispute and post-secondary education failed to become an important issue in the election. The CFS basically had no campaign specifically on post-secondary education, and refused to participate in the KSA's campaign.

I am extremely disheartened by what has happened at my school. There are times when I have believed that the goals that our organizations and leaders put forward were the actual goals and values we are trying to achieve. This dispute, more than any other fight I have been engaged in on tuition or funding or against corrupt deans and administrators or just the fight for the right of students to have a voice at the policy table; this dispute has taught me that corruption wins, and that countless people will turn their backs on the values and ideals they espouse if it suits them politically or gives them some kind of gain. It is a sad time for students in Canada.
